WAIVER AND RELEASE OF LIABILITY

I, (name of adult participant) _____ OR (name of minor child participant) _____ (hereinafter "Participant"), HEREBY WAIVE AND RELEASE, indemnify, hold harmless and forever discharge Living Fulfilled Institute, LLC and its agents, employees, officers, directors, affiliates, successors and assigns (the "Released Party"), of and from any and all claims, demands, debts, contracts, expenses, causes of action, lawsuits, damages and liabilities, of every kind and nature, whether known or unknown, in law or equity, that Participant may have arising from or in any way related to Participant's participation in any events or activities conducted by, on the premises of, or for the benefit of, Living Fulfilled Institute, LLC, provided that this waiver of liability does not apply to any acts of gross negligence or intentional, willful or wanton misconduct.

I understand that the activities that Participant will see and participate in are inherently dangerous and may cause serious or grievous injuries, including bodily injury, damage to personal property and/or death. Participant will be in direct contact with animals that include but are not limited to: dogs, rabbits, chickens, ducks, donkeys, miniature donkeys, and horses, among other animals that may not be listed.

I understand that animals may react in an unpredictable way to sounds, sudden movements, people, or other animals that could result in injuries to Participant. On behalf of myself, Participant, my heirs, assigns and next of kin, Participant waives all claims for damages, injuries and death sustained to Participant or Participant's property, that Participant may have against the Released Party.

By this waiver and release of liability, Participant assumes any risk, and takes full responsibility and waives any claims of personal injury or death or damage to personal property with Living Fulfilled Institute, LLC, including, but not limited to, visiting the facility, observing or interacting with the animals, using the facility and its equipment in any manner, form or fashion, and practicing and/or engaging in other related activities including the initiating of prohibited contact with the animals on and off the premises and disobeying any regulations both posted and unposted. It is a condition of entry that visitors observe all warning signs, do not venture over safety barriers and do not enter any off-limit areas.

This WAIVER AND RELEASE OF LIABILITY (this "Agreement") contains the entire agreement between parties and supersedes any prior written or oral agreements between the parties concerning the subject matter of this Agreement. The provisions of this Agreement may be waived, altered, amended or repealed, in whole or in part, only upon the prior written consent of all parties. The provisions of this Agreement will continue in full force and effect even after the termination of the activities conducted by, on the premises of, or for the benefit of Living Fulfilled Institute, LLC, whether by agreement, by operation of law, or otherwise.

I understand and confirm that by signing this Agreement Participant has given up considerable future legal rights. I have signed this Agreement freely, voluntarily, under no duress or threat of duress, without inducement, promise or guarantee being communicated to me. My signature is proof of my intention to execute a complete and unconditional WAIVER AND RELEASE of all liability to the fullest extent of the law. I am eighteen (18) years of age or older, I am Participant's legal guardian (if applicable), and am mentally competent to enter into this agreement.
